

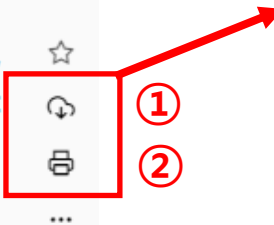

OPINION OF MR ADVOCATE-GENERAL WARNER  
DELIVERED ON 7 NOVEMBER 1973

*My Lords,*  
Your Lordships will remember that in 1962 the Council adopted a series of Regulations having as their object the gradual establishment in the then Member States of a common organization of the markets for certain agricultural products, with a view to the eventual creation of a single Community market for each of those products. In the present four cases (Cases 119, 124, 125 and 126/73) the Court is concerned with two of those Regulations, namely No 19 of 4th April 1962, which related to cereals, and No 22 of the same date, which related to poultry meat. More particularly it is concerned with the provisions of those Regulations which relate to the levies imposed individually to protect their respective agricultures. Under that system of levies each Member State was enabled to continue to protect its own agriculture against imports both from other Member States and from third countries, though to a lesser extent in the case of the former than in the case of the latter. In 1967 Regulations No 19 and No 22 were superseded by, respectively, Regulation No 120/67/EEC of the Council and Regulation No 123/67/EEC of the Council, which established the common organization of the Community markets in cereals and in poultry meat, involving the removal of all protective barriers as
